SKATE CANADA BRITISH COLUMBIA/YUKON SECTION VOLUNTEER AGREEMENT

WHEREAS Skate Canada British Columbia/Yukon Section requires and appreciates the support it receives from volunteers in connection with the delivery of world class skating competitions;

AND WHEREAS the undersigned ("Volunteer") desires to provide services to Skate Canada British Columbia/Yukon Section on a voluntary basis in support of upcoming events (the "Event" meaning any upcoming competition);

NOW THEREFORE Volunteer agrees as follows:

- Volunteer agrees to provide voluntary services to Skate Canada British Columbia/Yukon
 without remuneration of any kind and to carry out such services as are requested by Skate
 Canada British Columbia/Yukon to the best of his or her ability and to comply with all lawful
 directions and instructions received from Skate Canada British Columbia/Yukon in carrying
 out the services.
- 2. Volunteer understands and agrees that there may be risk of personal injury associated with the provision of services and further agrees to perform such services in a safe manner.
- 3. Volunteer agrees to attend any training or orientation session in connection with services provided by Volunteer at the request of Skate Canada British Columbia/Yukon.
- 4. In the event Volunteer is unable to provide consent, due to illness or injury, Volunteer hereby consents to the administration of first aid and other emergency medical treatment for such injury or illness that may occur during Volunteer's participation in the Event.
- 5. Volunteer agrees to keep confidential all information and other material of a sensitive nature which Volunteer may receive or have access to with regard to the Event that Volunteer knows or ought reasonably to know is confidential.
- 6. Volunteer agrees to provide a criminal records or background check at the request of Skate Canada British Columbia/Yukon. Furthermore, Volunteer acknowledges that the right of Volunteer to provide services in respect of the Event is conditional on the satisfactory outcome of the criminal records or background check as determined by Skate Canada British Columbia/Yukon in its sole discretion.
- 7. Volunteer acknowledges that Volunteer may provide personal information to Skate Canada British Columbia/Yukon as a result of Volunteer's participation, which personal information is subject to Skate Canada's Privacy Policy. Volunteer expressly acknowledges that his or her personal information may be shared with the LOC or other affiliates of Skate Canada for the purposes of administering the Event and such other purposes described in Skate Canada's Privacy Policy.
- 8. Volunteer agrees to release and hold harmless Skate Canada British Columbia/Yukon and its affiliates, including LOC, and all others associated with the event including sponsors and other participants, from any and all liability, claims, demands and causes of action that may result, directly or indirectly, from Volunteer's participation, including, without limitation, claims that arise as a result of the loss of or damage to personal property or claims rising from injury or illness or the provision of first aid or medical treatment of any kind.

9. Volunteer acknowledges that this Agreement is governed by the laws of the Province of British Columbia and Yukon Territory and the laws of Canada applicable therein.
